




Detailed specifications of the required item(s):-

Technical Specifications for Bio-safety Cabinet

1. Should be internationally reputed Brand (European, USA only)
2. Particulate contamination and hazards including Exceeds biological agents (viruses and bacteria) at Bio-safety levels 1, 2, & 3
3. Nominal width: 4 feet
4. Certification: Safety tested with NSF-49. NSF -49 (certificates must be attached as a proof)
5. Airflow Pattern: 100% exhaust
6. The blower motor should be able to automatically compensate its speed against the loading filter for the full life of the HEPA / ULPA filter without needing any user intervention.
7. Blower motor should be DC-driven and of the latest technology.
8. The cabinet should be fitted with illumination facility and Programmable UV-light.
9. In order to ensure consistent and reliable downflow velocity across the supply HEPA filter over the life of the cabinet, the cabinet must use a pressure sensor (rather than anemometer) to detect pressure drop across the supply filter, rather than in just one point across the downflow.
10. The pressure sensor must be encased in order to protect the sensor from temperature, humidity and other environmental phenomena that can impact the sensor's performance.
11. The intensity of lighting inside the cabinet should be 90fc or more .
12. The microprocessor controller must be located on a slanted front panel so it is easy to see and reach from a seated working position in front of the cabinet.
13. The interior of the front window must be accessible for cleaning without requiring the user remove or support the window.
14. The noise level must be 65 DBA or less.
15. Service fixtures for gas and water supply
16. The system should be provided with a suitable Adjustable base stand from the original manufacturer.
17. Visual and audible alarms for warning if any safety parameters are incorrect.
18. Power consumption: Not to exceed 0.30kw.
19. Power supply: 230V, +/-10%, 50 Hz
20. The supplier should have installed at least 5-10 Biosafety cabinets in India. At least 2-3 installation of the similar system with NSF-49 certification in the same campus (Please attaché User List with performance certificate)
21. Standard Warranty should be 24 Months or more.
