Technical specifications for Dental work station

The Dental Work Station should be veterinary specific for use in canine and other small animals. Dental work station should have heavy duty hospital grade coasters, Stainless steel stand, hospital grade powder coating inside & outside of air tank with drain valve, silent oil free compressor having 5 years warranty, dental control top with Hospital grade powder coating inside & outside, built in magnetic burr holder impervious to bacteria, cartridge valve system for all air & water valves, exhaust collection bottle with bacterial filter, 2 water bottle system (Distilled Water & Chlorohexidine solution) including water filters, Low speed hand piece for polishing, LED high speed hand piece with swivel coupling & self-generating LED dynamo (without fiber optic wiring), head turbines with no bacterial suck back and cross contamination. The system should have completely autoclavable suction system including tubing, hand piece & tips. Should include low Speed 20,000 rpm hand piece motor forward and reverse to be attached with low speed autoclavable contra-angle hand piece for vet endodontics along with aerosol lubricant and its spray cap. Should have 3 way syringe (air, water and mist). Should be fitted with piezo ultrasonic veterinary scaler with three different veterinary scaling tips which are autoclavable. Should have 14 piece dental instruments set for small animals, 13 piece extraction set for small animals & 3 piece mouth gag sets for canine.

The system should be supplied with veterinary dental extraction system for canines and other small animals with Ultra-thin flexible tips to have easy insertion into the periodontal ligament space on all canine teeth and ability to follow the curve of the root. The tip should be 40mm long to reach the apex of canine teeth, the replaceable tips should come straight out from the end of the hand piece, The extraction system should have non-twisting action and should not generate heat, should have 10 or more adjustable power settings and

different sized veterinary specific tips. It should operate independent of other air driven units.

The system should be supplied with light and small, portable X-Ray machine to be used in any location. The X-ray machine should produce small dose of radiation for patient and operator safety, should have high performance Tube and HFG, providing sharp and clear images, Should be fitted with remote operating switch and comply with National Safety Standards and guidelines. The X- Ray machine should have parameters of at least 60 kV fixed, 2mA fixed, 0.8mm focal spot with Hand strap and Neck strap. The system should be veterinary specific.

The complete dental work station along with all accessories mentioned above should be manufactured by a single firm. All parts of dental workstation except compressor should have 3 years warranty. The service center should be available in India and the company must certify to provide service within 48 hours in case of breakdown. Company should have previous record of similar or same unit in Veterinary Institutions in India or abroad and should provide the list of installations along with supply Order, customer contact details. Complete transportation, delivery, installation and commissioning, handing over shall be done by firm. The supplier should ensure that the above said equipment is ready to use without any additional financial liabilities. The company/firm should not be blacklisted / debarred by any Govt. institute during the last 5 years.
