


Specifications for ETO sterilizer


Machine should be a table top model. The chamber inner dimension should be at least 30cm (Height) x 30cm (Width) x 60cm (Depth). The chamber and all contact parts shall be made from high grade **Stainless Steel** & with a **flat door**. The Sterilizer should be operated on '**single use disposable type, 100% EO gas cartridge**'. Entire cycle process should be carried out in Vacuum, **negative pressure**. Cycle temperature, aeration time & pressure should be indicated on the panel. The chamber temperature should be controllable for Warm and Cold cycles. Cartridge should be **punctured inside the chamber**. Chamber should have '**inbuilt aeration facility**'. Faults & cycle status should be indicated on the LED panel. Should have strong degassing system to eliminate all the ETO gas. Sterilizer should be provided with removable SS trolley for keeping the materials to be sterilized.


Should have minimum 50 installations in Punjab and more than 500 installations of the similar equipment across India; list for the same should be provided along with the phone numbers. Supplier should have own service network in Punjab. The Cartridges and consumables should be readily available in Punjab (List of stores should be provided). The company should give a written undertaking that the consumables and repair support should be provided for a minimum 5 year period from the date of purchase. Machine should be supplied with compressor at 100 PSI pressure. Machine should be supplied with sealing machine & sterilization Rolls. In view of the safety concerns the firm should be reputed like Pest control India, 3M, Anderson or equivalent. Company must have installations in reputed institutes like PGI, AIIMS, DMCH / CMCH or equivalent etc. (Proofs of the same should be attached). Should be supplied with warranty of atleast two years. ETO sterilizer unit should be in completely installed as per standard safety norms and should be supplied in working condition. Complete installation of ETO sterilizer will be the responsibility of the firm. The machine should be fully functional with no additional financial liability on the part of the university.



Any optional accessories/ tooling, besides the standard equipment recommended for the better performance of the equipment, if offered, be provided with their full technical details including their use and advantage in a separate sheet with the tender documents. The item should be delivered F.O.R. at GADVASU/Research Stations/KVKs/Colleges etc. as mentioned in Tender document and the supplier shall be responsible for any damage during the transit of goods.
