


Technical Specifications for Refrigerated Centrifuge with Rotor

1. Should be of international reputed/brand
2. Temperature range of -10C- + 40C,
3. Maximum RPM \geq 15,000 rpm, at least RCF 25,000xg
4. Maximum capacity 1600 ml
5. Should be microprocessor controlled with direct brushless induction maintenance free drive/motor
6. Digital graphic LCD display of time, speed, rcf and temperature
7. Rotor lock should be auto lock push button for easy working
8. Must have pre cooling function.
9. Changing of rotors should be hassle free (No need of tools)
10. The angle rotors should be of carbon fiber with warranty of atleast 12 to 15 years.
11. The centrifuge must be supplied with corrosion and fatigue resistant carbon fiber material
Angle head rotor 6x100 ml with 50 ml, 15 ml and 1.5/2.0 ml adaptors along with PP tubes (> 13,000 RPM)
12. Should have advanced imbalance technology
13. The centrifuge must be ISO 13485,, CE certified attach certificate
14. Must specify all technical standards
15. Should be supplied with a compatible servo controlled stabilizer (Minimum 2KW).
16. There should be a minimum of 2 years comprehensive Warranty.
17. Original equipment manufacturer must have presence in India for at least 5 years.
Minimum of at least 50 such centrifuges installed in India (Users List in India should be attached).
18. The supplier must attach the authorized dealership certificate from the manufacturer/distributor.
