



REVISED TECHNICAL SPECIFICATIONS FOR LARGE ANIMAL X RAY MACHINE (1000mA, 80KW DIGITAL X RAY)

The X-Ray machine should be state of art and latest technology for use in radiography of large animals, Veterinary and animal sciences. System should have following Configurations and technical Parameters:

S. No.	Technical Specifications
1	High frequency X-Ray generator having frequency higher than 30 KHz.
2	Automatic exposure control for constant output with minimum 80KW or higher. KV range should be atleast 40kV-150kV, mA range should be 1000 mA for large animal radiography, Should have overloading protection.
3	The control panel should have Digital display of kV, mA and exposure time, Switches to adjust kV, mA and exposure time and Anatomical programming for different radiographic applications should be possible.
4	The X-Ray Tube should have dual focus rotating anode which is thermally protected and should have multi leaf collimator with auto shutoff with bright light source and cross hairs for collimation.
5	Tube should be with anode heat storage capacity of 400 kHU or more.
6	Atleast two out of three major components of the X-ray machine i.e. X-ray tube, X-ray generator and control panel, should be manufactured by single firm.
7	The tube stand should be ceiling mounted with three dimensional movements of the tube head.
8	The horizontal movement should be more than 250cm and Vertical movement of the tube should be atleast 160 cm for x-ray of the foot in standing animal. Transverse movement should be more than 150 cm and Tube rotation on its own axis should be more than 180°.
9	A compatible 100 KVA voltage stabilizer for complete radiographic system should be supplied.
10	The machine should include a Compact Bucky Table with Single position, Horizontal X-ray Examination Table (Floating Table top)
11	The table should be fitted with movable Catapult Bucky having high quality grid at least 8:1 ratio & density 100 lines per inch.
12	The X-Ray machine should have Online UPS for Digital System with Minimum back up time of 15 Minutes.
13	It should have complete image processing Unit including atleast 19" HD monitor and all relevant software for radiographic use of Large animals, Veterinary and animal sciences.
14	One additional CPU with Graphic and Video card along with HD Monitor atleast 21" for acquiring the X-Ray images and interpretation
15	The machine should be supplied with 1 flat panel detector (14"x17") and 1 CR system with 4 CR 14" x 17" cassettes along with printer having 2 or more trays. All the parts should be from the same manufacturer to ensure compatibility. Lead Aprons- 2 Nos, Thyroid Shield - 2 Nos, Gonad Shield - 2 Nos & Lead Goggles- 2 Nos and Long Length Portable Imaging System.
16	Networking for the unit with Main reporting room along with PACS/RIS/HIS System should be provided
17	The unit should be as per AERB safety standards
18	The X-Ray machine should have a Flat Panel Detector which should be able to do all routine Radiography examination

19	The Flat Panel Detector size should be of at least 35 x 43 cm or more and should have a pixel pitch of 150 micron or less.
20	The detector should preferably have amorphous silicon with cesium iodide scintillator or advanced feature. Image matrix size at least 2k x 2k or more

The system should conform to the following Instructions and Regulatory Approvals:

1	The Main Unit must have US FDA or European CE approval with 4 digit notified number.
2	Company should have previous record of similar or same unit in Veterinary / medical Institutions in States of Punjab & Haryana or other states
3	Company should provide the list of installations along with supply Order, customer contact details.
4	The company/firm should not be blacklisted / debarred by any Govt. institute during the last 5 years.
5	Company should have Service center in Punjab/Chandigarh, please furnish the details
6	Complete unit should have warranty of 5 years including, spare+ Labor+ X Ray Tube+ all accessories

9	Company will have rights to visit the site under approval of the HOD of the concerned department
10	The supplier should ensure that the above said equipment is ready to use without any additional financial liabilities
11	The buyback value of the old X-ray machine must be clearly mentioned in the quote
12	Firm must quote CMC price of post warranty period for the next 5 years. These rates will be taken into consideration for deciding L1.
13	As this machine will be used for clinical research purpose, so GST exemption will be applicable, as per university rules.

The Bidder shall not tamper/modify downloaded price bid template in any manner. In case if the same is found to be tempered/modified in any manner, tender will be rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with GADVASU.
- (b) The bidders are advised to quote price for equipment in INR.

3. Any change/corrigendum/extension of opening date in respect of this tender shall be issued through websites www.gadvasu.in and www.eproc.punjab.gov.in only and no press notification will be issued in this regard. Bidders are therefore requested to regularly visit these websites for updates. Bidder should also take into account any all corrigendum(s) published before submitting the bids online.

6. The quoted equipment shall be in compliance with the required specifications mentioned in tender and shall be of the latest technology, best quality and high standards. Any optional accessories/ tooling, besides the standard equipment recommended for the better performance of the equipment, if offered, be provided with their full technical details including their use and advantage in a separate sheet with the tender documents. No extra payment shall be paid on account of any discrepancy in nomenclature of items.
7. The item should be delivered F.O.R. at GADVASU/Research Stations/KVKs/Colleges etc. as mentioned in Tender document and the supplier shall be responsible for any damage during the transit of goods. 15. The quantity can be increased/decreased as per the actual requirement.
16. The bidder is required to furnish the non-blacklisting certificate as per Annexure – III.
17. While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any tender stipulate any condition of his own, such conditional tender is liable to be rejected.
