The successful bidder will have to deposit refundable security equal to six months license fee before taking possession of the drug store and furnish a bond on non-judicial stamped paper for Rs. 100/- within three working days failing which the bid will be granted to the next highest bidder. 5.	Payment: That the Licensee fee will be deposited by the Licensee in the first week of every month failing which the Licensee will pay fine of Rs. 500 per day for the license fee not paid. If the license fee is unpaid for up to three months, the outstanding amount of the license fee will be recovered from the security deposit of the Licensee. 6.	<p><u>Terms and Conditions for allotment of Drug Store</u></p> <ol style="list-style-type: none"> 1. Each drug store will be considered a separate independent entity. 2. Drug store(s) will be allotted to the highest successful bidder. 3. The validity of the contract under tender will be a maximum up to Three Years. 4. The minimum reserve price for the license fee shall be Rs. 75,000/- per month. 5. The contract will be renewed every eleven months with minimum 10% annual increase in previous year's license fee. For renewal of contract, licensee should submit application 2 months before the completion of contract period. 6. The payment of the applicable taxes time to time is sole responsibility of the licensee. 7. License fee can be increased over and above the 10% increase and re-fixed at the time of next extension/ renewal of agreement, which will be effective from the date of renewal of agreement. 8. Extensions in allotment will be at the sole discretion of Vice-chancellor. 9. The drug stores will remain open around the clock (24 hours) 7 days a week, failing which action will be taken. 10. Licensee should have a valid license from the competent authority for the sale of drugs. 	

11. Allottee should also have license for sale of blood collection bags and scheduled drugs like anesthetics/ opioids etc. and shall have to maintain record of the sale of such drugs as per govt. norms. The allottee shall be responsible for compliance of norms /regulations of the Government notified from time to time and the University shall not be liable for any noncompliance by the allottee.
12. The Licensee will have to get his own electricity connection from the PSPCL in his own name and bear the costs for it.
13. The Licensee will give **minimum of 10% discount** on MRP of drugs/items. The discount should be displayed clearly visible place both in English & Punjabi.
14. That the allottee will have to deposit an additional refundable **security equal to six months of license fee for each drug store.**
15. That the drug stores facility will be accepted by the Licensee on as is where is basis and furnishing/repairs etc. will be arranged by the Licensee at his/her own cost. Permanent alteration/construction in the drug store can be made by the Licensee in consultation with Estate office.
16. Permanent fixtures such as shuttering, gates, windows, grill etc. will not be allowed to be removed after completion of contract.
17. The Licensee will carry on the business only of veterinary medicine and related items etc.
18. The Licensee will not be allowed to sub-let drug store.
19. In case of any misconduct on the part of the Licensee, the agreement will be terminated without assigning any reason and without any notice.
20. In case Licensee wants to terminate the contract, the Licensee will have to give two month notice in advance to GADVASU. If the GADVASU wants to terminate the contract, it will have to give two months' notice to Licensee.
21. Recovery of credit, if any to any party, will be the sole responsibility of the Licensee.
22. Any other Term/Condition imposed by the GADVASU regarding allotment/termination/enhancement of the contract will equally be applicable to the Licensee.
23. That the Licensee fee plus taxes will be deposited by the Licensee in the first week of every month failing which the Licensee will pay fine of Rs. 500 per day for the license fee not paid. If the license fee is unpaid for up to three months, the outstanding amount of the license fee will be recovered from the security deposit of the Licensee. The Vice Chancellor may also cancel the allotment of the drug store in case of such lapse.
24. The quality of drugs, maintenance, hygiene and service of the drug store will be monitored by a committee.
25. The licensee will have no right to contest if any product/medicine is provided by the University for Treatment of animals.
26. That the licensee shall comply with all the rules and regulations of the university as adopted and made applicable from time to time.
27. Range of generic medicines should be available at the drug store and sold at the approved rates (not at the printed rate.) with preference to generic drugs.
