The sealed tenders must reach in the office of the undersigned latest by 10:30 am on 26.03.2019 (Tuesday). The tenders will be opened immediately thereafter in the office of undersigned in presence of such tenderers as may like to be present at their own expenses in the office of the undersigned. The quantity and the number of ingredients mentioned are tentative and may change at the time of placing order. The rates should be mentioned in per quintal for **net weight only, FOR GADVASU Dairy Farm, including unloading**. The bags used for supplying the materials must be in good condition and its cost may be mentioned separately or may be included in the cost of feed ingredients.

Terms & Conditions:

1. Tender will not be accepted after due date and time (i.e. 10:30 noon on 26.03.2019) and by telegram and extra conditions.
2. Rates (including the cost of bags if any) should be mentioned in per quintal for net weight only, **FOR GADVASU Dairy Farm**, including unloading. The bags used for supplying the materials must be in good condition. Weight of empty bags will be deducted from the gross weight received while reaching the figure on net weight.
3. Rates should be mentioned both in words and figures. Cutting & overwriting will not be allowed.
4. The rates quoted should be including all taxes and no extra tax and (C) or (D) form will be paid/given.
5. The quantity of feed ingredients mentioned is tentative and can be increased or decreased according to availability of funds and quoted rates. The exact quantity will be mentioned in the supply order.
6. The supply of feed ingredients must be completed within 5 days of issuance of supply order and **part supply (30% - 40% of the total supply order) must be made within two days of issuance of supply order.**
7. The feed ingredients to be supplied should be in good quality and free from fungus and any adulterants. Otherwise the consignment will be returned immediately.
8. The supply of feed ingredients should be made to Incharge Feed Stores, Dairy Farm, GADVASU, Ludhiana.
9. The analysis of samples of feed ingredients will be done in University labs and their reports will be final for decision to be taken by Incharge Feed Store.
10. If there is any discrepancy between the two parties, the Director, Livestock Farm. will be the final authority to decide about issue. The decision of Director, Livestock Farms will be applicable to both the parties.
11. University reserves the right to reject any or all tenders without giving any reason.
12. **A sum of Rs 50,000/- (Rs Fifty Thousand only) in the form of Demand draft & call deposit receipt (Cheque will not be accepted) in the favour of Comptroller, GADVASU, Ludhiana as earnest money should also be enclosed along with tender. Tenders without earnest money will not be accepted.**
13. Earnest money will be retained as security whose rates for any item found to be lowest, and whose rates were not accepted, their earnest money will be refunded on next working day.
14. Security will be refunded after 15 days of the completion of supply of material.
15. Other terms & conditions not listed in this form, if any will be announced at the time of opening of tenders.
16. Tender rates will be valid upto 31.03.2019 and firm will be bound to supply the quantity of repeat order.
17. The supply of the material ordered has to be made up to minimum of 95% of the ordered quantity. No payment will be made for the excess quantity than the ordered.
