

Specification of Large Animal Handling Chute**


- Should have Revolving Rump Bar, operated by an external wheel which is fitted with a strong ratchet lock, to provide safe control at the rear end of the animal, even when the side doors are open.
- Should have safety Floor - made from at least 5mm steel plate covered with non-slip reinforced rubber and solid steel grip bars, so that animals can walk on and the absence of any "trough" in the base of the crate gives a flat surface to assist in suckling or fostering calves.
- Should have shaped Doors to accommodate each animal without permitting undue movement.
- Should have Full Access to Lower Half of Animal - Pairs of steel doors should extend the full length of both sides, with centrally located, easy opening spring catches. When open, the door should give unrestricted access to the animal's lower half.
- Should have easy access to the top line as there is no vertical loop or obstruction to prevent a continuous sweep with the clippers and/or pour on and yet the animal cannot move out of position or step out of the crate.
- Should have Dimensions:
  - Overall width 36" plus 5" for revolving rump bar handle
  - Overall height 85"
  - Overall length adjustable upto 96"
  - Internal clearance 30"



**The firms are also required to upload copies of the following documents in a single file of .pdf format with Technical Bid:-**
