

- f) The e-books should be readable on various devices including PCs, Laptops, mobile, e-book reader, etc.
- g) RBI/ Nationalized Bank conversion rates on the date of invoice will be applicable. Proposals on Good Office Committee (GOC) conversion rates will not be entertained.
- h) The vendor/ aggregator must have GST number, which should be mentioned on proposal.
- i) The Library may increase or decrease the number of titles of e-books to be purchased depending upon the availability of funds.
