# CHAPTER II

#### 2.1 Introduction

# (A) College of Veterinary Science, Ludhiana

The College of Veterinary Science was set up in 1969 as a constituent college of the Punjab Agricultural University, Ludhiana. With the formation of new university, it became a part of the Guru Angad Dev Veterinary and Animal Sciences University in 2006. The college has 17 departments with excellent laboratory facilities and infrastructure for



undergraduate (UG) and postgraduate (PG) teaching and research.

The college owns a well-established Livestock Farm Complex comprising of an elite dairy herd, a poultry farm, a goat farm and a piggery unit. Multi-Speciality Veterinary Hospital caters to the need of large and small animal healthcare. The college has distinction of having three Indian Council of Agricultural Research (ICAR) Centers of Advance Faculty Training in Veterinary Surgery and Radiology, Veterinary Gynaecology and Obstetrics, and Veterinary Pathology.

Bachelor of Veterinary Science (B.V.Sc. & A.H.) degree is designed to equip the graduates with the knowledge and skills essential for a career in Veterinary Science and Animal Husbandry as per Veterinary Council of India (VCI) norms. The programme is divided into three phases: the pre-clinical phase to provide education in basic aspects such as Veterinary Anatomy, Physiology, Biochemistry, Genetics, Breeding and Extension. The para-clinical phase includes bridging subjects between the pre-clinical and clinical phases such as Veterinary Pathology, Microbiology, Public Health, Epidemiology, Parasitology, Pharmacology, Toxicology, Nutrition, Livestock Farm Practices and Livestock Products Technology. The clinical phase includes Veterinary Surgery & Radiology, Medicine, Gynaecology and Obstetrics. At the end of the course work, the students undergo a compulsory rotational internship programme.

Successful completion of B.V.Sc. & A.H. programme entitles the graduates to seek mandatory registration with Punjab State Veterinary Council/Veterinary Council of India as a Registered Veterinary Practitioner. The college is recognized by VCI and all the ongoing UG and PG programmes in the college have been accredited by the ICAR with 'A' grade.

# (B) College of Veterinary Science, Rampura Phul, Bathinda

The College of Veterinary Science, Rampura Phul, Bathinda was established as a constituent college of Guru Angad Dev Veterinary and Animal Sciences University, Ludhiana. The foundation stone of the college was laid on 30th October, 2014.





It became functional on October 1, 2019 by admitting 80 students to the B.V.Sc & A.H. programme with the VCI approval. The mandate of the college is to produce veterinary graduates to overcome the deficiency of veterinary professionals in the state. In addition, its endeavor will be to implement the research outputs and extension education programmes for better livestock health and production, especially in the South-Western zone of Punjab. The college campus comprises of college buildings, veterinary hospital, farms, playgrounds and fodder production area. The residential complex comprises of hostels, guest house and staff quarters. All 17 departments as per MSVE-2016 guidelines viz. pre-clinical (Veterinary Anatomy, Physiology, Biochemistry, Genetics & Breeding, Livestock Production Management and Veterinary & Animal Husbandry Extension Education) para-clinical (Veterinary Pathology, Microbiology, Public Health & Epidemiology, Parasitology, Pharmacology & Toxicology, Nutrition, Livestock Farm Practices and Livestock Products Technology) and Clinical (Veterinary Surgery & Radiology, Medicine, Gynaecology & Obstetrics and Veterinary Clinical Complex) departments are established and functional with excellent laboratory and infrastructure facilities.

- c) Candidates must have passed 10+2 standard level examination with a minimum of 50% marks in individual subjects of Physics, Chemistry, Biology and English.
- d) The eligibility of qualification will be subject to verification of equivalence with the 10+2 examination of any recognized Education Board of India.
- e) The candidates must furnish the details of subjects studied, grades and percentage equivalent marks in the relevant columns of NRI/OCI Application Form.
- f) The syllabus of the courses studied at 10+1 and 10+2 level, contact details and the website address of the institute attended needs to be attached with the application.
- g) Mere submitting of the application does not guarantee admission to the programme.
- h) Priority will be given to the candidates of Punjab and Union Territory of Chandigarh origin.

Their suitability for admission to undergraduate programmes will be assessed by the committee consisting of the Dean of the college concerned (Chairperson), the Chairperson of Academic Affairs Committee and the Secretary of Board

- of Studies of the college concerned (members). For postgraduate programmes, the committee will consist of the Dean, Postgraduate Studies (Chairperson), the Dean of the college concerned (member) and the Head of the concerned department (member).
- iv. The International/ Foreign students seeking admission must have a valid student visa, declared medically fit after examination (as per Annexure F) by the Medical Officer authorized by the Indian Embassy in the home country of the student and they must have full medical insurance for entire period of study/stay in India.
- v. The International/Foreign students will be charged an Institutional Economic Fee @ US \$ 2000 per year per student of SAARC country and US \$ 4000 for a student from countries other than SAARC countries or as per specific provisions of the scholarship/fellowship and as amended from time to time by the sponsoring agency. The Institutional Economic Fee will be charged for the period prescribed for a particular programme.
- vi. The Institutional Economic Fee may not be charged from the candidates admitted by the Govt. of India under certain fellowship/scholarship such as Nepal Aid Fund, Colombo Plan, Indian Technical and Economic Cooperation Programme, General Cultural Scholarship and Cultural Technical Exchange as per specific provisions of the scholarship/fellowship, or as amended from time to time by the sponsoring agency.
- vii. However, above candidates will have to deposit tuition fee, admission fee, hostel dues and other usual charges for the period they remain enrolled in the programme as applicable as per University rules or as per specific provisions of the scholarship/fellowship, or as amended from time to time by the sponsoring agency.

# CHAPTER III

# **COLLEGE OF DAIRY SCIENCE AND TECHNOLOGY**

#### 3.1 INTRODUCTION

College of Dairy Science & Technology, Ludhiana is one of leading institution of dairy education and research at national level. It was established in the year 2008 as one of the constituent colleges of GADVASU, to meet the trained manpower requirements of dairy and food industry. To impart the quality education and training of students it is equipped with excellent infrastructure in terms of state-of-the-art classrooms and laboratories with advanced analytical instruments facilities.

Moreover, the college also has an Experimental Dairy Plant which is working round the year and facilitates Handson-Training of students. Besides physical infrastructures, college is also blessed with a pool of young and dynamic faculty with an exposure of working at premier institutes of international repute. Accreditation of our academic programs by ICAR, New Delhi with 'A' grade in itself reflects the quality of education and training imparted at this college.

Job oriented undergraduate program of B. Tech. (Dairy Technology) is one of the most sought after and flagship program of the college. It is a four-year degree program during which students are trained in such a way so that they fit in for both technical and managerial jobs in dairy and food industry. The college also provides facility of Campus Placement. Most of the students get job offer through campus placements. Industries like Verka, Amul, Nestle, Baani etc. have previously visited campus to hire the students through campus recruitment.



The college also offers Masters degree in five disciplines i.e Dairy Technology, Dairy Engineering, Dairy Chemistry, Dairy Microbiology and Agricultural Economics. The college also offers Ph.D programme in these disciplines except Dairy Chemistry. During their degree program Master's and Ph.D students are exposed to conduct theme specific research, generate data and documentation in the form of thesis, research papers, patent etc. The college has number of active collaborations with industry and academic/ research institutes at national and international level which gives our students an opportunity to work and learn under dynamic research environment. Besides working in different dairy and food industries in India our students are also spread across the world in countries like USA, New Zealand, Canada, Australia etc. for their higher education and jobs.

To meet the requirements of skilled floor level workers in dairy and food industries from 2022-23 academic session the college has started two new short courses of 8 weeks duration with intake capacity of 10 candidates per batch.

# CHAPTER IV

# **COLLEGE OF FISHERIES**

#### **4.1 INTRODUCTION**

College of Fisheries (COF), one of the constituent colleges of GADVASU, was established in April, 2008, to produce professionally competent human resource (graduates and postgraduates) to serve the fisheries sector in different capacities (teaching, research, extension, planning and livelihood generation) for holistic development through productivity enhancement and socio-economic

sustainability. Since its establishment, the College has registered a commendable academic growth and has made significant R&D contributions for the development of the inland fisheries sector in the north-western region of India. With five departments, competent experienced faculty, smart classrooms, fully equipped modern laboratories and a well-developed "Instructional cum Research Farm" (spread over an area of 6 ha), COF, GADVASU possesses hi-tech facilities for effectual teaching, capacity building (experiential learning, skill development, trainings and demonstrations), advanced research and extension programs.

Fisheries college is accredited by the ICAR with "A" grade and is offering undergraduate (UG) and postgraduate (PG) degree programs in different disciplines of fisheries. The course curriculum of its four-year UG degree program, Bachelor of Fisheries Science (B.F.Sc.), is being offered as per Indian Council of Agricultural Research (ICAR)-5th Deans' Committee Recommendations and is divided into eight semesters. During the first 3 years (1st to 6th semester), students are taught different courses (theory and practical) covering various aspects of fisheries and they undergo 'STUDENT READY PROGRAM' during the last year (7th & 8th semesters) of the degree program, including:i) In-Plant Training (8 weeks), Rural Fisheries Work Experience (RFWE) (8 weeks) and 1-Month "Study Tour" during 7th semester and ii) Experiential Learning, Skill Development (1-Week) and Project Development Program during the 8th semester, to instill entrepreneurial proficiency among the



fishery graduate for self-reliance.

The curriculum of the PG degree programs offered by the College viz. 2 years Master of Fisheries Science (M.F.Sc) and 3 years Doctor of Philosophy (Ph.D.), is also based on ICAR- BSMA (Broad Subject Matter Area) regulations, comprising of course work and research project towards submission of thesis/dissertation as an integral part for award of respective degree.

The minimum eligibility qualification for admission to Master's programmes of the university is OCPA/OGPA of 6.000/10.000 or 60% marks in aggregate in the Qualifying Bachelor degree (in respective discipline as shown in table under Sr. No. 6.2.2) from a recognized institute/college/university established by law in India.

#### 6.2.2 Master's Programme (In-service Candidates)

The minimum requirement for in-service candidates for admission to Master's programmes in the constituent colleges of the university is OCPA/OGPA of 5.500/10.000 or 55% marks in aggregate in the Qualifying Bachelor degree (in respective discipline as shown in table under Sr. No. 6.2.2) from a recognized institute/college/university established by law in India. Candidate should be an employee of any Government/Semi-government department of Punjab/Union Territory of Chandigarh and have a minimum of two years professional experience (after completion of Bachelor's degree) in these departments on the last date of receipt of application.

#### Note:

(i) The in-service candidate will be considered for admission only if his/her application is duly forwarded through proper channel by the Head/sanctioning authority after certifying that during the study period salary will be paid as per rules and lien will be retained, and on completion of studies the candidate will join back on the said post.

- (i) Candidates resident of Punjab and Union Territory of Chandigarh as per merit based on OCPA/OGPA/percentage of marks of qualifying degree.
- (ii) Candidates other than residents of Punjab and Union Territory of Chandigarh (who have already applied as per specified date) on the basis of MET-Vet 2023-24 Score (Weightage-70%) and Qualifying degree Examination (Weightage-30%).
- (iii) Candidates other than residents of Punjab and Union Territory of Chandigarh (who have already applied as per specified date) as per merit based on OCPA/OGPA/percentage of marks of qualifying degree.

# (b) Master's Programmes (Other than M.V.Sc. programmes and M.Sc.-Molecular Biology & Biotechnology with specialization in Animal Biotechnology):

Candidates resident of Punjab and Union Territory of Chandigarh as per merit based on OCPA/OGPA/percentage of marks of qualifying degree. The vacant seats thereafter, if any, will be filled up from Candidates other than residents of Punjab and Union Territory of Chandigarh (who have already applied as per specified date) as per merit based on OCPA/OGPA/percentage of marks of qualifying degree.

#### (c) M.Sc. Molecular Biology & Biotechnology (with specialization in Animal Biotechnology)

Merit of eligible candidates based on Rank/Score obtained in Graduate Aptitude Test-Biotechnology (GAT-B) conducted by the Regional Centre for Biotechnology on behalf of the Department of Biotechnology (RCB-DBT), Government of India.

#### 6.2.4 Eligibility and Selection Criteria for Master's Programmes (NRI/OCI)

As per merit based on OCPA/OGPA/percentage of marks of qualifying degree and similar to General category candidates. Please refer to Table under Sr. No. 6.2.2 and Sr. No. 6.5.

#### 6.2.5 Breaking of Tie in the Merit List

- (i) If combined score of MET-Vet 2023-24 and qualifying degree examination are same, candidate with higher marks in MET-Vet 2023-24 shall be ranked higher, followed by candidate older in age.
- (ii) In case of the tie in cumulative score for Ph.D. programmes, a candidate getting higher percentage of marks in qualifying degree examination shall be ranked higher, followed by the candidate older in age.

### 6.3 Eligibility and Selection Criteria for Ph.D (3 years) Programmes (including NRI/OCI Category)

#### 6.3.1 Ph.D. Programmes (Other than In-service Candidates)

The minimum eligibility qualification for admission to Ph.D. programmes of the University shall be an OCPA/OGPA of 7.000/10.000 or 70% marks in aggregate in the Master's degree and OCPA/OGPA of 6.000/10.000 or 60% marks in aggregate in Bachelor's degree from a recognized institute/college/university established by law in India. The eligible Master's and Bachelor's degree for admission to specific Ph.D. programme are given against respective discipline in the table below:

#### 6.3.2 Ph.D. Programme for In-service Candidates

The minimum eligibility qualification for admission to Ph.D. programmes of the University for in-service candidates shall be the same as in case of other than inservice candidates (Sr. No. 6.3.1). Candidate must be an employee of a University/National Institute/Punjab Government/Union Territory of Chandigarh/Central or State Government/Semi- Government organizations/ Affiliated colleges of GADVASU offering degree program and having at least two years of experience of Teaching/ Research/ Extension.

#### Note:

- (i) The in-service candidate will be considered for admission only if his/her application is duly forwarded through proper channel by the Head/sanctioning authority after certifying that during the study period his/her lien will be retained and on completion of studies, the candidate will join back on the said post.
- (ii) The preference for admission under in-service category will be given to the candidates working

with Government/Semi- Government organizations of Punjab/ UT of Chandigarh followed by Affiliated colleges of GADVASU and other State candidates on case-to-case basis.

#### 6.3.3 Selection Criteria for Ph.D. Programmes

Eligible candidates' resident of Punjab and Union Territory of Chandigarh will be considered as per the merit based on cumulative score derived from marks obtained in qualifying degree examination and in the interview as per the following formula:

Cumulative score =  $\{(90 \times A)/100\}$  + B

Where A = Percent marks obtained in the qualifying degree examination B = Marks obtained in the interview out of 10

#### Note:

- (i) To be eligible for Ph.D. admission, a candidate must secure a minimum of 50% marks in the interview.
- (ii) The vacant seats, thereafter, if any, will be offered to candidates from other states (who have already applied and appeared in the interview) as per above said merit criteria.

# 6.4 Admission Procedure for Masters and Ph.D. Programmes

#### 6.4.1 Admission Procedure

- (i) Candidates for admission to Master's programmes are required to submit a copy of online submitted application form, along with the self-attested copy of transcript of academic records/final year detailed marks/certificate (as per checklist given at Chapter VI, Section 6.4.2), proof of payment of requisite application fee, as a single pdf file, through email at gadvasuadmission2023pg@gadvasu.in (gadvasuadmissiongatb@gadvasu.in for M.Sc. under GAT-B) to reach Registrar, GADVASU office on or before the last date fixed for receipt of application form. Proof of rank/score achieved in GAT-B, if applicable, should also be submitted at above email within seven days of declaration of result (RCB-DBT) or as notified on the university website, failing which the claim for admission shall stand cancelled. The submission of the hard copy of application will not be considered.
- (ii) Another "Admission Form" for admission to PG programmes, will be available on the university website at least one week before 1st counselling. The duly filled Admission form along with self-attested copies of all the relevant documents (as per checklist given at Chapter VI Section 6.4.2) must be submitted by the candidate at the time of counselling. All the original certificates/documents are required to be submitted/shown to the Selection/Counselling Committee, failing which the candidate will not be considered for admission.
- (iii) The University will prepare a category-wise merit list of the applicants based on the competitive and/or qualifying exam for the programmes.
- (iv) Merit based on competitive examination will include candidates securing equal to or more than cut off marks as per category.
- (v) The candidates seeking admission to a programme must attend the counselling as per the schedule to be displayed on the university website.
- (vi) No separate intimation will be sent for counselling. For consideration of admission, the candidate must be physically present at counselling as per schedule. Absentees, for any reason whatsoever, will not be considered for admission.
- (vii)Once the seat is allotted, no shifting among categories/ colleges/disciplines will be allowed during the same

counselling.

- (viii)In case of seats falling vacant after surrendering during a counselling will be filled only in the subsequent counselling(s).
- (ix) In case of Ph.D. programmes, the seats remaining vacant during the 1<sup>st</sup> semester may be filled in the next semester, if required. Updates in this regard will be published/notified on the University website.

# 6.4.2 Check-list of the documents to be submitted at the time of counselling

- (vi) Income certificate for candidates under SC/ST category who wish to claim fee concession and whose annual family income is below Rs. 2.5 lakhs for claiming Post-Matric Scholarship (Annexure I, Form-B).
- (vii)Income certificate for candidates under BC category (Annexure II, Form B).
- (viii) Income and assets certificate for candidates under EWS category (Annexure XIII).
- (ix) Self-undertaking of gap in study period, if applicable (Annexure X).
- (x) Undertaking regarding Anti-Ragging (Annexure XI- A, B).
- (xi) Certificate for in-service candidates, if applicable (Annexure VIII).



#### Note:

- (i) The eligibility under reserved category(ies) will be determined only on the basis of option(s) claimed while submitting the online application form. Any claim for reservation at later stage will not be entertained. The supporting document(s) in prescribed format shall be produced at the time of counselling.
- (ii) Candidates must produce original documents before Selection Committee at the time of Counselling [Refer Rule No. 7.1 (xvi) of Chapter VII]

## 6.5 Admission Procedure and Guidelines for NRI/ OCI Category

### 6.5.1 Eligibility Criteria

- (i) The seats under NRI/OCI category will be in addition to the seats for resident candidates.
- (ii) Only the NRIs/OCI or their children/wards (as per the judgment of Honourable Supreme Court for Appeal (Civil) 5041 of 2005) are eligible to apply.
- (iii) Merit will be based on OCPA/OGPA/percentage of marks of qualifying degree.
- (iv) The NRI/OCI candidates seeking admission to postgraduate programmes are not required to appear in MET-Vet 2023-24 or any other entrance test.
- (v) NRI/OCI candidates must fulfill eligibility criteria prescribed for resident Indian students.
- (vi) The eligibility of qualification will be subject to verification of equivalence with Indian degree(s) as in Table under Sr. No. 6.2.2 for Master's programme and Table under Sr. No. 6.3.1. for Ph.D. programmes.
- (vii) Mere submitting of the application does not guarantee admission to the programme.
- (viii) Preference will be given to the candidates/wards/ children of Punjab and Union Territory of Chandigarh origin (Please attach proof).

### **6.5.2 Application Procedure**

(i) The application form may be downloaded from the university website (www.gadvasu.in), duly filled in all respects, along with proof of payment of requisite application fee, self-attested copies of the relevant documents/certificates showing grades/ marks and conversion formulae for calculating percent equivalent marks (as per check-list at S.No. 6.5.4), all these scanned into a single pdf file should be submitted through email at gadvasuadmission2023nri@gadvasu. in to reach the Registrar, GADVASU office on or before the last date fixed for receipt of application form.

- (ii) The candidates must furnish the details of subjects studied, grades and percentage equivalent marks in the relevant columns of NRI/OCI Application Form.
- (iii) The syllabus of the courses studied at Bachelor and Master's degree level (as applicable), contact details and the website address of the institute(s) attended needs to be attached with the application.
- (iv) At the time of counselling, candidate is required to present/submit copies of the submitted application form and original certificates.
- (v) At the time of registration, the candidate will bring original certificates for physical verification.

### 6.5.3 Application Fee (Non-refundable):

- (i) Application and processing fee of US\$ 750/- or equivalent Indian currency should be credited in the university account either online [account detailed at Sr. No. 6.9.2] or offline (in shape of bank demand draft, in favour of "Comptroller GADVASU" payable at Ludhiana). In addition to US\$ 750/-, Foreign Bank Charges/Correspondent Bank Charges, GST on Foreign Transactions will be borne by the candidate. In case of Indian currency, equivalent certificate of US\$ exchange rate issued by bank is to be submitted.
- (ii) The application not accompanied by the confirmation/ receipt of the payment of requisite application fee will not be considered.

- (c) In Master's programmes in College of Fisheries and College of Animal Biotechnology, one additional seat in each discipline may be filled under Selffinanced category.

#### (iii) Economically Weaker Section (EWS) Category:

- (a) In College of Veterinary Science (COVS) Ludhiana, in Master's programme four additional seats may be filled under EWS category. For seat allotment, all the Master's disciplines in COVS are divided into four groups viz., Group A - Veterinary Surgery & Radiology, Veterinary Medicine, Animal Reproduction Gynaecology and Obstetrics and Veterinary Pathology; Group B – Veterinary Public Health & Epidemiology, Veterinary Parasitology, Veterinary Pharmacology & Toxicology and Veterinary Microbiology; Group C - Veterinary Anatomy, Veterinary Physiology, Veterinary Biochemistry and Veterinary Extension Education; Group D - Animal Nutrition, Animal Genetics & Breeding, Livestock Production Management and Livestock Products Technology. One seat each will be there for the four groups of disciplines. Based on their merit, candidates can opt for one discipline out of these four groups in a given academic year. In subsequent year(s), the next candidate cannot opt for the same discipline in which seat has been allocated in previous year(s) till all the disciplines have been covered in a group as per the roaster.
- (b) In Master's programmes in College of Dairy Science & Technology, College of Fisheries and College of Animal Biotechnology, one additional

- seat in each college may be filled under EWS category. Based on their merit, candidates can opt for one discipline in their respective college in a given academic year. In subsequent year(s) the next candidate cannot opt for the same discipline in which seat has been allocated in previous year(s) till all the disciplines have been covered in a college as per the roaster.
- (iv) One additional seat under Sportspersons/NCC Cadets category is reserved in Master's programme of College of Veterinary Science Ludhiana, and shall be filled up in different disciplines of the college, following a roaster. This seat may be allotted as per choice of the candidate. However, the same discipline where the students in earlier years have been admitted under Sportspersons/NCC Cadets category, shall be allowed only after a gap of three years. Other rules and guidelines as mentioned elsewhere in the prospectus will remain the same.
- (v) In Master's programme, there will be one additional seat for Kashmiri migrants in each constituent college. This seat may be allotted as per the choice of the candidate in each college. However, the same discipline where a student in earlier years have been admitted under Kashmiri Migrant category, next candidate shall be allowed only after a gap of three years.
- (vi) In Master's programmes, not more than one candidate, out of the Sportspersons/NCC Cadets and Kashmiri Migrants category will be admitted in any one discipline as per the merit list among these categories of eligible candidates. However, preference will be given to Sportspersons/NCC Cadets category.
- (vii)In no discipline, all the seats will be allowed under reservation categories, and at least one seat will be made available under open quota.
- (viii) In postgraduate (Master's and Ph.D.) programmes, one additional seat in each discipline may be filled under in-service category.
- (ix) Seats remaining vacant under 'ICAR Nominee' category will be filled up on open merit basis from all other eligible candidates as per university procedure.
- (x) The fee structure and number of seats in any programme and category can be changed by the competent authority of the University without any notice.

Other requisite fee and charges, however, will have to be paid by the student subject to the followings:

- a) The student must submit the rough draft of the thesis/ dissertation to the office of Dean Postgraduate studies by the last date of dropping a course.
- b) Further, the final thesis/dissertation must be submitted within 30 days in case of Master's programme and 60 days in the Doctoral programme after the submission of rough draft of thesis/dissertation.
- c) Dean Postgraduate Studies may grant permission for

extending the time period for submission of final thesis/dissertation, in case a student of Master's and Ph.D. programme fails to submit the final thesis/dissertation within 30 and 60 days, respectively after submission of rough draft of thesis/dissertation (within the same semester, otherwise student has to register for next smester), with the late fee for extended period as per following norms.

# **CHAPTER VII**

# 7.1 General Important Information Applicable to All the Categories of Students

- (i) Candidates may download the prospectus from the University website (www.gadvasu.in) and should carefully read the eligibility criteria, admission rules, etc. before applying for admission.
- (ii) For M.V.Sc. programme, candidates undergoing internship can also apply. However, they must have completed all the requirements for the award of B.V.Sc. & A.H. degree before registration date.
- (iii) Candidates (except NRI/OCI/Foreign Nationals/ Government/VCI/ICAR nominee/GAT-B) seeking admission to various undergraduate and postgraduate programmes of the university must apply "online" at the university website by the due date and time.
- (iv) To avoid any kind of inconvenience or last minute rush and/or any unforeseen difficulties, the candidates are advised to submit application forms without waiting for the last date.
- (v) Only one application is to be submitted for consideration for admission to a particular programme. Submitting more than one application for a particular programme is liable for rejection of candidature.
- (vi) The residents of Punjab or Union Territory of Chandigarh, candidates nominated by VCI/ICAR/ICCR, NRI/OCI candidates and candidates for other states are eligible for seeking admission to different programmes of university as indicated. The Dean of the concerned college in consultation with the Dean, Postgraduate Studies may constitute Committee(s) under the chairmanship of Associate Professor/Professor to verify documents, determining the eligibility and accordingly recommending admission to eligible ICAR candidates as per norms of the University/ ICAR.
- (vii) The candidates who have applied under Sportsperson/NCC Cadet Category (Annexure-A or B) and under Armed Force Category (Annexure

IV-A or B) must submit the supporting document(s) by the date as will be notified on the university website, in the office of Director of Students' Welfare-cum-Estate Officer (for Sportspersons and NCC Cadets) and Registrar (for Armed Force Category), failing which, claim for admission under the said category(ies) shall stand cancelled.

- (viii) Counselling/Interview will be as per dates and schedule mentioned in the prospectus and/or notified on the University website. No separate call/invitation letter will be made to the candidate.
- (ix) The prescribed dates will not usually be changed, even if dates are declared as holidays. However, if any change is mandated due to any exigency, it will be notified on the University website (www. gadvasu.in). Candidates are advised to check the university website an evening prior to every activity pertaining to admission for update(s), if any.
- (x) It is mandatory for a candidate to report personally for counselling/interview as per scheduled date, time and venue.
- (xi) The applicants shall be called for counselling on the basis of merit in descending rank, one after the other. If a candidate called for counselling, does not present himself/herself before the Selection Committee, his/her claim for any seat shall get forfeited. In case, the candidate reports after his/her name has been called for counselling but within stipulated time on the day of counselling, the seat offered to that candidate shall be out of the remaining seats available at the point of time when he/she reports before the Selection Committee.
- (xii) If a candidate misses any scheduled counselling, he/she can attend the subsequent counselling(s), but he/she will be considered for admission on the basis of merit against the remaining vacant seats only.
- (xiii) The date/schedule of Special Counselling(s)/ Mop-up Round(s)/Walk-in-Interview and other update(s) if any, will be notified at the University website. The candidates are advised to visit the



- University website regularly.
- (xiv) The candidates appearing for counselling to UG or PG programme(s) are required to fill the respective Admission Forms, which will be available at the University website at least one week before the first counselling. The Forms should be downloaded from University website. Duly filled Admission Forms along with a set of self-attested copies of all the relevant documents as per Check List of Documents available in the said form and mentioned in the prospectus at Sr. No. 7.2 and 7.3 (as applicable) is to be submitted by the candidate at the time of counselling.
- (xv) The candidate must bring original certificates, documents and testimonials (as per check-list) to be verified by the Selection Committee, failing which his/her candidature will not be considered for admission. A candidates can also get his/her documents verified from the Selection Committee through Digilocker.
- (xvi) At the time of counselling, the Selection Committee shall also consider the past record of the candidate. If, it is known that the candidate has been involved in any act of indiscipline in the hostel/ college/school/institute or in organizing unlawful demonstrations, etc., the Selection Committee may refuse admission to such candidates. The candidate, who has been expelled/ rusticated or debarred by any university/institute, shall not be admitted. Hiding of facts whatsoever may attract disqualification of a candidate, if it so warrants, as and when such facts come to notice of the university. Such candidates will have no rights for any type of refund of fee.
- (xvii) Once the seat is allotted, no shifting among quotas/ colleges/disciplines will be allowed during the same ongoing counselling.
- (xviii) The selected candidates shall have to deposit the Demand Draft/fee immediately after counselling agreeing to the terms and conditions. The Selection Notice will be issued only after the deposit of fee by the candidate as per prescribed procedure.

- (xix) The selected candidates are required to submit the medical fitness certificate to be issued by the University Medical Officer. The medical examination fee of Rs. 875/- will be charged by the University Health Centre. Any candidate found medically unfit, shall be entitled to refund of admission fees. In such cases the application for refund must be submitted within 14 days from the issue of Selection Notice.
- (xx) The university will not pay any T.A./D.A./or any other expenses for appearing in the counselling.
- (xxi) The seats remaining vacant under reserved categories, if any, shall be offered to the candidates competing an open merit basis.
- (xxii) The status of vacant seats, if any, will be available on the university website at least one day prior to the 2nd/3rd counselling/interview. The date of Special Counselling(s)/Mop-up Round(s)/Walk-in Interview, if any, will be notified on the University website. The candidates are advised to visit the university website regularly for update(s).
- (xxiii) No admission shall be made after the last date of admission, unless date(s) for Special Counselling(s)/
  Mop-up Round/Walk-in-Interview is/are notified by the university on the website.
- (xxiv) The students admitted to the various academic programmes in the University shall have to abide by all the rules and regulations (as applicable) of the Guru Angad Dev Veterinary and Animal Sciences University, Ludhiana.
- (xxv) The admission obtained by a candidate due to misrepresentation/concealment of facts or admission made due to error/oversight at university level, can be cancelled at any stage.
- (xxvi) All the programmes of the university are full time residential programmes (except specific UG/PG Diploma, Certificate and Short courses). A student, therefore, cannot be admitted to more than one programme at a time in this or any other university/institute.
- (xxvii) Admission to all the UG and PG programmes (except specific UG/PG Diploma, Certificate and Short Courses) in the university is made by

- the Registrar on the recommendations of the Chairman Counselling /Selection Committee.
- (xxviii) The Registrar may, at his discretion, cancel the admission of a candidate if at any time, it is found that the candidate obtained admission by misrepresentation/concealment of facts or the admission was made due to error, oversight, etc.
- (xxix) The Academic Council of the University is the supreme authority to frame rules and regulations, and to decide all other matters relating to admissions and academic affairs. The Academic Council also has the right to promote or discontinue any programme and also to increase or decrease seats in any programme, whatsoever.
- (xxx) The fee structure and number of seats in any programme and category can be changed by the competent authority without any notice.
- (xxxi) The University reserves the right to enhance the fees, charges, funds, etc. at any time. An Annual incremental increase of 10% in the fee structure shall be applicable to the constituent and affiliated colleges of the university, excluding tuition fee of Self-financed/Category-II seats of constituent colleges and Management/ Special Management quota seats of affiliated private college. However, there will be no increase in tuition fee for the students of M.Sc. (Molecular biology and Biotechnology) with specialization in Animal Biotechnology under DBT-Postgraduate teaching programme admitted through GAT-B.
- (xxxii) Any litigation arising for the fee being charged from the students will be dealt by the constituent/ affiliated college itself.
- (xxxiii) In case of hosteller students, the electricity bills received in excess of the electricity fund collections, shall be proportionately charged from the residents of the respective hostels.
- (xxxiv) The securities not claimed for three semesters succeeding the semester in which the student leaves the college either by completing a particular degree programme or dropouts or otherwise, shall be forfeited. In case of interns, claims for refund of hostel security shall be entertained after the

- completion of the internship programme.
- (xxxv) All claims for refund of hostel security shall be entertained through the concerned college.
- (xxxvi) Hostel accommodation shall be provided subject to availability only.
- (xxxvii) In UG programmes requests for surrender of seat as well as claim for refund of fee (if applicable) accordingly be submitted to the Dean/Principal of the college concerned. In PG programmes, the similar requests should be submitted through the Head of the department (in which candidate has sought admission) to the Dean PGS and the concerned Dean of the College for "surrender of seat" and "refund of fee", respectively. Copy of Selection Notice must be enclosed with the said requests.

- (iv) Self-declaration (Annexure VII) and a self-attested copy of the Residence Certificate obtained from the competent authority in the prescribed format (Annexure VII A) as per instructions/guidelines of Punjab Government (Annexure-E).
- (v) Income certificate for candidates under SC/ST category with annual family income below Rs. 2.5 lakhs for claiming Post-Matric Scholarship and/or fee concession (Annexure I, Form-B).



- (vi) Income and assets certificate for candidates under EWS category (Annexure XIII)
- (vii)Income certificate for candidates under BC category (Annexure II, Form-B).
- (viii) Self-undertaking of gap in study period, if applicable (Annexure X).
- (ix) Certificate for In-service Candidates (Annexure VIII).
- (x) Undertaking regarding Anti-Ragging (Annexure XI-A, B).
- (xi) Latest Copy of Aadhar Card of Candidate and his/ her mother.
- (xii)Self-attested copy of Election Photo Identity Card (EPIC). The candidates who do not have an EPIC card must apply for the same at the website of Election Commission of India as per FORM-6 (Annexure XII).

Note: The eligibility under reserved category(ies) will be determined only on the basis of option(s) claimed while submitting the online application form. The supporting document(s) in prescribed format shall be produced at the time of counselling. Any claim for reservation at a later stage will not be entertained.

# 7.3 Check-List of Documents to be Submitted for NRI/OCI Category

The candidates must submit scanned self-attested photocopies of the following documents, in single pdf file, along with the application form:

- a) Birth certificate,
- b) Citizenship/permanent resident certificate and
- c) Passport or any other valid document justifying their NRI/OCI status,.
- d) Educational qualification certificates and mark sheets issued by the recognized Board/University from 10th class onwards.
- e) Character Certificate from institution last attended.
- f) Self-undertaking of gap in study period, if applicable (Annexure X).
- g) Undertaking regarding Anti-Ragging (Annexure XI- A, B).
- h) The original documents will be verified at the time of registration.

# 7.4 Rural/Border Area Reservation and Refund Policy

#### 7.4.1 Rural and Border Area Candidates Reservations

The reservation of 5% and 2% under categories 'Rural Area' and 'Border Area' candidates, respectively against additional seats for admission to various undergraduate programmes being offered by all the constituent colleges of the University. The criteria for admission under these categories is as under:

#### **Border Area**

Candidate must be from a village/town within the belt of 10 K.M. from the International Border and has studied there for at least five years and has passed public examination (Matric or Higher Secondary Part-1) from a school located in border village/town (excluding the District towns of Ferozepur and Gurdaspur). Two certificates, one from the DC/GA to DC of the District or SDO (Civil)/SDM for the village/town being within 10 K.M. limit from the International border, and another from the Head Master/Principal of the institution with details of exact date of joining and leaving the school/college must be produced along with the application form.

#### **Rural Area**

The candidate will have to produce a certificate from SDM/GA to DC of having studied for a minimum of two years and passed Matric and Higher Secondary Part-1 or +2 from a school which is situated in rural area. The school should not fall within the limits of any Municipal Committee, notified area or a Cantonment Board. Schools like Dashmesh Academy and those situated in University Campuses, Nangal Township and Talwara Township are excluded from the list of schools in the rural category. The candidate should also be a permanent resident of a rural area (village).

# 7.4.2 Refund Policy for All Undergraduate & Postgraduate Programmes

Depositing of fee on shifting/sliding and refund of fee for new entrants shall be as per the following procedure:

 The students taking admission as per their interest/ choice, in case shift/slide their seats within the constituent colleges/ disciplines of the University during subsequent counsellings can do so without depositing the fee repeatedly. The balance refundable amount of fee after deductions would be refunded after the admission is closed for that Academic Year.

- 2. Any excess amount in case of higher fee is to be paid by such Students immediately after the counselling as per provisions at S.No.(xviii) under section 7.1 of Chapter VII of the University Prospectus 2023-2024.
- 3. The revised Refund Policy in the University (constituent and affiliated colleges) for new entrants other than NRIs/Foreign Nationals will be applicable detailed as under: -

If a student chooses to withdraw from the programme of study in which he/she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees\* remitted by the student:

S. No.	% age of Refund of Fee*	Point of the time when notice of withdrawal of admission is received the HEI
(1)	100%	15 days or more before the formally-notified last date of admission.
(2)	90%	Less than 15 days before the formally- notified last date of admission.
(3)	80%	15 days or less after the formally- notified last date of admission.
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission
(5)	0%	More than 30 days after formally- notified last date of admission.

#### Note

- (a) The concerned college shall deduct an amount not more than 5% of the fees paid by the student subject to the maximum of Rs.5000/- as processing charges from the refundable amount.
- (b) In case of Sr. no. 5 mentioned in above table, only the caution money/refundable security shall be refunded to the student.
- (c) The last counselling conducted by the university will be the formally notified as last date of admission

# 7.5 Fee Concession for All Undergraduate & Postgraduate Programmes

University may grant fee concession to the needy students having financial difficulty in continuing with their studies on merit-cum-means basis. The different controlling officers can remit tuition fees in academic programmes as proposed below:

- 1. The Dean of the concerned college (Except College of Veterinary Science, Rampura Phull) can remit tuition fee of upto 10% of students in each UG class (Academic year wise). In these 10% students, 3% will be granted 100%, next 3% will be granted 50% and remaining 4% will be granted 33.3% concession in tuition fee. The students with lowest family income will be given priority in higher slab of fee concession. However, the girl students will be given priority in full tuition fee concession to promote education of a girl child from the economically weaker sections.
- 2. The Dean Postgraduate Studies can remit upto 33.3% tuition fee of upto 10% of students of all the Masters Programmes combined together having been admitted in a respective college during a given academic year on the recommendation of Head of the Department and Dean of the concerned college.
- 3. The Dean Postgraduate Studies can remit upto 33.3% tuition fee of upto 10% of students of all the Ph.D. Programmes combined together having been admitted in a respective college during a given academic year on the recommendation of Head of the Department and Dean of the concerned college. This will be mainly on the basis of merit and the means (if warranted).

The proposed general guidelines to be followed in all the above cases are given below:

#### A. General criteria:

- The eligibility of the student will be on merit-cummeans basis to help such students having financial difficulty in continuing with their studies.
- ii. The students interested in availing fee concession must submit their application/form along with requisite document(s)/certificate(s) such as an affidavit with respect to the family income (income certificate from Tehsildar as per Annexure with details of income from different sources) and academic profile in the concerned Dean/Principal office within one month of their registration for timely processing of the application for fee concession/refund/adjustment.

# B. Wards of Working and Retired C and D Employees of the GADVASU:

The fee concession may be granted up to two wards



of the working and retired group C and D employees of GADVASU. A concession of 66.7% in tuition fee will be given to the first and 33.3% to the second child. However, the girl students will be given priority in full tution fee concession to promote the education of a girl child from the economically weaker section.

### C. Admission Fee and Other Charges from SC Students under Post Matric Scholarship Scheme:

Students admitted under SC category, whose parents/guardian's annual income is less than Rs.2.50 lakhs and is availing Post-Matric Scholarship as per guidelines of Government of India and Punjab Government, may be granted a full concession in admission/tuition fee and other non-refundable charges.

#### D. Fee Concession for Sports Persons and Co-Curricular Activities

The students participating in sports and co-curricular activities in official events recognized by the AIU/ICAR/National Federations/Associations shall be given the following concession:

Sportsmen/Women/Artists who participate in an officially sponsored International competitions or secure 1st, 2nd and 3rd position in Sr. National/ All India Inter-Varisty in Sports Tournaments/Youth Festivals can be granted upto half tuition fee concession upto 2% of the students in a given degree programme.

The Committee consisting of the following will consider eligible students for the above fee concession(s) and make its recommendations to the Director Students' Welfare-cum-Estate Officer:

Dean of the College - Chairperson

Director Human Resource Management Cell – Member Secretary, Sports Committee of the College –Member

The Dean will submit these recommendations to the Director Students' Welfare-cum-Estate Officer for his/her consideration/approval. After approval, the Director Students' Welfare-cum-Estate Officer will send the case to Vice Chancellor for the final sanction of fee concession. After sanction from Vice Chancellor, the Dean of the College concerned will issue the necessary orders regarding fee concession to the students.

#### Note:

- i. The students who have won the above positions during an academic session will be eligible for half fee concession during the following academic session.
- ii. Eligible students will apply during the second semester of the each academic session and the concession will be granted for the following academic session.

# Note: General conditions applicable to all categories of students availing fee concession

- (i) Fee concession is not a matter of right of the student. University can increase or decrease percent of students to be granted fee concession, extent of fee concession, amount of fee concession, limit of income of their parents/guardian to be eligible for fee concession or any other condition.
- (ii) Annual income of the parents/guardian of the student from all sources should be below the basic taxable limit, without allowing any exemption/deduction, for the corresponding Financial Year as fixed by the Income Tax Department.
- (iii) The Dean will submit his/her recommendations to the Vice Chancellor for approval of the case including extent of concession. After sanction from Vice Chancellor, the Dean of the College concerned will issue necessary orders regarding fee concession to the students applicable under different categories.
- (iv) The minimum percentage of marks in qualifying examination should be 60% and subsequently in second year of study at University it should be a minimum OCPA/OGPA of 6.00 out of 10.00 in case of Diploma and Undergraduate Programmes and OCPA of 7.00 out of 10.00 in case of Masters and PhD Programmes (This condition will not be applicable for SC students availing Post Matric Scholarship).
- (v) The tuition fee concession may be granted subject to the condition that the student is regular in attendance and that he/she has satisfactory progress in his/her studies, which should be certified by Advisor/Major Advisor of student.
- (vi) The concession may be withdrawn on misconduct/ indiscipline on the part of the student, irregularity in attendance or failure or unsatisfactory grade in any of

the courses in any examination.

- (vii) The students placed on Conduct Probation or failed to achieve "Good Standing" will not be considered for any fee concession for that period. Also, the students who are re-admitted after having been dropped under Semester and/Annual Rules as applicable in degree programme, as envisaged in the Semester and Hostel Rule, will not be eligible for fee concession during the first year of their re-admission.
- (viii) The students admitted under self-financed (including all BVSc & AH admissions to College of Veterinary Science Rampura Phul) and all NRI categories are not entitled to fee concession.
- (ix) Employed parents/guardians are required to obtain income certificate from their employer and for any additional income from other sources, they would furnish declaration by way of an affidavit on nonjudicial stamp paper.
- (x) The students who are awarded any other scholarships/ fellowships are also eligible for this benefit of fee concession with the condition that the annual income of the parents/guardian of the student from all sources should be below the basic taxable limit, without allowing any exemption/deduction, for the corresponding Financial Year as fixed by the Income Tax Department and provided that the already awarded scholarship does not cover more than 50% of tuition fee.
- (xi) Applications will be invited within one month of admission to a particular course/year in prescribed

format.

- (xii) Committees for deciding the number of students to be given fee concession in a given programme and amount of fee concession to be given will be decided by the following committees as per study programme:
  - a. Dean Postgraduate Studies/Dean of College/ Director Students' Welfare-cum-Estate officer.
  - b. Senior most Head of the Department of the college concerned.
  - c. Senior most Professor from the college concerned.
  - d. Welfare Officer (Convener)

# 7.6 Mop-up Round(s)/Special Counselling(s)/ Walk-in Interview:

- (i) The detail of the Mop-up Round(s)/Special Counselling(s)/Walk-in Interview, if any, for filling up vacant seats under Self-Financed/Category-II/ Management/Special Management Quota will be notified on the university website.
- (ii) Said seats, remaining vacant (other than reserved for other state candidates) after considering the candidates from Punjab & UT Chandigarh will be offered to the candidates from other states provided they meet all the eligibility requirements as notified by the University, have applied within stipulated dates and have paid requisite fee.
- (iii) Sliding/shifting of the candidates from one Quota to another or from one college to another will not be allowed in Mop-Up Round(s)/Special Counselling(s)/ Walk-in Interview, if any.



# CHAPTER VIII

### REGULATIONS REGARDING RUSTICATION AND EXPULSION OF STUDENTS

- The Dean/Principal of the college shall have the power to expel or rusticate a student for sufficient reasons, including acts of indiscipline and misconduct inside or outside the college.
- 2. Case(s) of rustication or expulsion of the student shall be immediately reported by the concerned Dean/Principal to the Registrar for registration and notification.
- The Dean/Principal may revise his/her decision within 15 days of passing the order of rustication or expulsion. The revised decision composed with reasons shall be communicated to the Registrar for placing before the Academic Council.
- 4. The period of expulsion/rustication shall be minimum of two semesters/one academic year to maximum of four semesters/two academic years.
- 5. The student under rustication shall have the option of rejoining the class during the ensuing semester after the expiry of the period of rustication.
- 6. It shall be obligatory for the college to re-admit a rusticated student, if he/she wishes to rejoin after the expiry of the rustication period.
- 7. The name of the rusticated student shall not be maintained on the rolls of the college and the student will not be charged any fee during the period of rustication.
- 8. A student expelled from the college shall not be allowed to seek fresh admission into the same or another college of the University without the sanction of the Academic Council. In no case, such a student shall be allowed to do so before the expiry of two academic years, excluding the academic year in which he/she was expelled.

 Any fact that makes the Vice-Chancellor consider that the order passed by the Dean/Principal requires revision, the Vice-Chancellor may bring the case to the notice of the Academic Council, after consideration of the matter, the decision of the Academic Council shall be final.

### 10. Instructions/Regulations Regarding Anti-Ragging

"Ragging" is strictly prohibited in the colleges as well as in the hostels. Any student found indulging in the act of ragging will be strictly dealt with according to the directions given by the Hon'ble Supreme Court of India. According to Raghavan Committee observations, ragging has several aspects including psychological, social, political, economic, cultural and academic dimensions. The anti- ragging committees and squads have been constituted at the college level to keep a check on the incidents of ragging. If found guilty, it may invite punishment up to the expulsion of the guilty student from the institute or registration of F.I.R. under provisions of the Indian Penal Code. Every student and his/her parents/guardian are supposed to submit following affidavits that the student will desist from ragging in any form:

- An annual undertaking to be signed by each student whether fresher or senior, and his/her parent(s) jointly stating that each of them have read the relevant instructions/regulations against ragging as well as punishments, and that if the ward has been found guilty, he/she should be proceeded against (Annexure XI-A, B).
- Undertaking should be provided in English as well as in the vernacular language (Annexure XI-A, B).

# **CHAPTER IX**

# REGULATIONS REGARDING R & V SQN. NCC, CCA, NSO AND NSS

# 9.1 Regulations Regarding R & V Sqn. NCC/NSS for B.V.Sc. & A.H. Programme

- 1. The students (except NRI/OCI/Foreign Nationals) admitted to B.V.Sc. & A.H. programme have to register for compulsory R & V Sqn. NCC course at COVS, Ludhiana and compulsory NSS course at COVS, Rampura Phul, each of 0+1 non-credit for the first three years (NCC/NSS I, II & III). The NRIs/OCI/Foreign Nationals have an option to enroll either NSS or Cocurricular activities (CCA) as non-credit compulsory course for three years.
- A student may be exempted from registering this course on medical grounds by the Vice-Chancellor on the recommendation of the Dean of the college. In such cases, the student has to produce the medical certificate from the university Medical Officer and consent letter from the NCC Officer.
- 3. The performance of the students in the course will be evaluated on the basis of the examination conducted at the end of each academic year. A 75% attendance in parades/course is mandatory; failure to do so will make the student ineligible to appear in the annual examination.
- 4. The students will be awarded with the Satisfactory (S)/ Unsatisfactory (US) grade.
- 5. If a student obtains 'US' grade in a group, he/she shall have to register for the same group of R & V NCC courses in the subsequent year. However, a student cannot register simultaneously for more than one group. If the student obtains 'US' grade at the end of 3rd year, he/she shall have to register for making up R & V Sqn. NCC deficiency in the 4th academic year in addition to regular courses.
- 6. It is mandatory for every student to attend one annual training camp in the 2nd year of B.V.Sc. & A.H. as a part of the degree requirement.
- 7. A student on successful completion of Group-I, Group-II and Group-III R & V Sqn. NCC courses and attending one annual training camp may be relieved

- from R & V Sqn. NCC, and he/she will be eligible to start his/her internship programme.
- 8. In case, due to some emergency, the R & V Sqn. NCC authorities are not able to arrange the compulsory annual training camp; the Vice-Chancellor may relax such regulations concerning the annual training camp, as it cannot be completed.
- 9. The Dean, College of Veterinary Science shall be the Overall in-charge for this programme.
- 10. The B.V.Sc. & A.H. students opting for the NSS programme will be governed by the rules mentioned at 9.2.2.

### 9.2 Regulations Regarding NSO, NSS and CCA

The students admitted in B.F.Sc., B.Tech. (Dairy Technology) and B.Tech. (Biotechnology) are required to participate in any one of the NSO, NSS and CCA programmes during the first and second year of the degree programme (as applicable). It is specified that the NSO will be assigned to only those students who show marked proficiency in sports. The programme of NSO shall be optional for the students other than in the first and second year. The foreign nationals are exempted from NCC/ NSO and shall have an option to register either NSS or Cocurricular activities (CCA). Immediately after admission, the concerned Dean/Director Students' Welfare-cum- Estate Officer shall enroll the students under the particular programme and submit the list to the Registrar for completing the personal files of the students. The students enrolled in a scheme, shall not ordinarily be allowed to change it afterwards.

#### 9.2.1 NSO

- Undergraduate students who register for NSO, shall complete the requirements in the first four semesters of their studies.
- The students opting for NSO training shall have to devote 150 hours of actual play in a year. Failure to attend 75% training period during a semester will lead to award of 'US' grade to the student. If a student fails



- to obtain 'S' grade at the end of second/fourth semester, he/she shall have to register for subsequent semester for making up deficiency of NSO training only, in addition to regular courses in the next semester.
- 3. Attendance of 75% training period in a semester/ year is compulsory. The Vice-Chancellor may grant exemption in NSO to a student on medical grounds on the production of a medical certificate from the University Medical Officer and recommendation by the Director Students' Welfare-cum-Estate Officer.
- 4. It is mandatory for the students undergoing NSO training to attend one training camp of 20 days within the first four semesters of training failing which he/she has to register for the next semester to enable him/her to make-up for the deficiency of the camp.
- A student who has undergone NSO training in some other college/institute for a complete academic year, may be exempted from NSO training for the period already completed by him/her, by the Director Students' Welfare-cum-Estate Officer.
- 6. If a student becomes physically unfit for NSO training on medical grounds or due to accident or is dropped for any reason, the Director Students' Welfare cum- Estate Officer may temporarily exempt such a student and he/she has to complete the training in the subsequent semester.

#### 9.2.2 NSS

- The enrolled students are required to attend the NSS for the first four semesters of their studies. However, for B.V.Sc. & A.H. programme students it will be for 3 years.
- 2. The student is required to put in a minimum of 120 hours per year in NSS. Failure to do so shall earn the student 'US' grade followed by a warning to make-up for the deficiency in the following semester/year. If a student fails to complete the deficiency and is awarded 'US' grade in 2nd/4th semester, he/she shall have to register for the 3rd/5th semester for making up for NSS deficiency, in addition to regular courses.
- 3. The Vice-Chancellor may exempt any student from NSS, on medical grounds on the production of

- a medical certificate from the University Medical Officer and recommendation of the Director Students' Welfare-cum-Estate Officer.
- 4. Aside from putting regular 120 hours in NSS, each student is required to attend two 7-10 days Special Camps. A day at camp is calculated as 7 hours of service. In case of failure to attend the camp, the student has to register for NSS in the next semester/ year to make-up for the deficiency of NSS camp, in addition to regular courses.
- A student who has undergone NSS training in some other College/Institute for a complete academic year may be exempted from NSS training for the period already completed by him/her, by the Director Student's Welfare-cum-Estate Officer.

#### 9.2.3 CCA

- 1. NRIs, OCIs and Foreign National students have an option to enroll either NSS or Co-curricular activities (CCA) of 0+1 (NC) for two/three years, as applicable.
- 2. In the CCA programme, the classes will be held for forty hours a semester or eighty hours a year for the two/ three years, as applicable.
- 3. A student enrolled under the CCA programme must attend a minimum of 75% classes held in a year. On failure to do so, the student will be awarded US grade and given a warning to make up for the deficiency in the following year. If he/she fails to complete the deficiency and is awarded US grade in the third year, he/she shall have to register for the same group for the purpose of making up for CCA deficiency in the next semester/year, in addition to regular courses.
- 4. A student may be exempted from CCA on medical grounds by the Vice-Chancellor, on the production of a medical certificate from the University Medical Officer and recommendation by the Director Students' Welfare-cum-Estate Officer.
- 5. The students undergoing CCA training are required to attend one annual training camp during the first two years of training.

# CHAPTER X

# SCHOLARSHIPS, STIPEND, FELLOWSHIPS, AWARDS, MERIT CERTIFICATES AND MEDALS

#### 10.1 Scholarships

#### (a) University Scholarship

This scholarship, valued at Rs. 1000/- per month, is awarded to the meritorious students of undergraduate programmes on the basis of score/rank/marks obtained in the qualifying test/examination merit list for admission. The number of scholarships is determined college wise by the academic council from time to time.

### (b) National Talent Scholarship (NTS)

The ICAR/VCI awards merit scholarships in undergraduate and postgraduate programmes for the full duration of the degree programme subject to fulfillment of prescribed conditions. The value of scholarship is Rs. 3000/- per month for UG student and Rs. 5000/- per month for PG student.

# (c) Post Matric Scholarship (PMS) Scheme-SC for the year 2023-24

It is a centrally sponsored scheme with a 60:40 sharing ratio between the Centre and States (90:10 in case of North Eastern States).

#### Eligibility

Scholarships will be paid to the scheduled caste students whose parents'/guardians' income from all sources does not exceed Rs. 2,50,000/- (Rupees two lakh fifty thousand only) during the last financial year. Income certificate is required to be taken once only i.e. at the time of admission to courses only which are continuing for more than one year. The income certificate shall be issued by the Authority as decided by the State Government.

The scholarship includes: Compulsory non-refundable fees including tuition fee, as fixed by the Fee Fixation/Rationalization Committee of the State Government and Academic Allowance (10% extra allowance for Divyang (physically challenged) students.

#### Freeship Card

All eligible students shall be entitled to take admission

in the institutions without pre payment of tuition fee and hostel fees (but will pay refundable charges) as per the **Scheme Guidelines** available on the site **https://scholarships.gov.in** under Ministry of Social Justice & Empowerment. To enable this, a **FREESHIP CARD** will be issued by the State Government to the eligible students. This Freeship card shall make the student eligible to study in the institution without pre-payment of the fees, and on the condition that as and when amount is released to the student's account, the institution would be intimated to collect the same from the student.

Student should have a valid functional Mobile Number, Aadhar Number (UID), Aadhar linked Bank Account, Income Certificate, Caste Certificate and Passing Certificate for applying on the Dr Ambedkar Scholarship Portal, Govenment of Punjab at www.scholarships. punjab.gov.in (select 'New Registration' from 14-04-2022 onwards). Well before the expected date of admission, the student shall register for issuance of a Freeship Card on the respective scholarship portal giving the details like the Aadhaar number, the name of the course in which he/she wants to take admission (e.g. M.Sc./ M.V.Sc./ B.V.Sc & AH./ B.Sc./ B.Tech./ Diploma, etc.) and an undertaking that the institution's charges would be paid within 7 working days from the date of receipt of the scholarship amount in his/her account. For the purpose of registration of Freeship Card, the portals shall remain open throughout the year. For the purpose of admission, the Freeship card will remain valid for period of one year from the date of issue.

Note: Those without Freeship card will have to deposit the full fee.

#### (d) PM Young Achievers Scholarship Award Scheme

A new scheme namely PM Young Achievers Scholarship Award Scheme has been formulated for OBC, EBC and DNT students as per letter no. BC-12013/10/2020-BC-I issued by the Ministry of Social Justice & Empowerment, GOI received through Director, Animal Husbandry, Pb



vide his memo No. 5737-38 dated 22.05.2023.

#### (e) Dr. G. S. Khush Scholarship

Two scholarships each for the students of B.V.Sc. & A.H. and B.Tech. (Dairy Tech.); and one scholarship for students of B.E.Sc. will be awarded by Dr. G. S. Khush Foundation for Agriculture Sciences @ Rs.1200/- per month. The scholarship will be awarded to the students from rural background only, on the basis of merit of NEET (UG)/JEE (Mains)/10+2 examination (as applicable) in first professional year and on the basis of OGPA/OCPA of the previous year for subsequent years.

#### (f) Sports Scholarship

The university awards the sports scholarship @ Rs. 1000/- per month on fulfillment of prescribed conditions. The number of scholarships are four for major games (viz., Hockey, Football, Athletics and Cricket) and four for the minor games.

# (g) DBT- Postgraduate Teaching Programme Scholarship

Each student admitted in M.Sc. (Molecular and Biotechnology) with specialization in Animal Biotechnology will be awarded Rs 5000/- per month as per the terms and conditions of DBT.

#### (h) Sh. Lilakrishan Jhangi Ram Galhotra Scholarship

Scholarship of Rs 2000/- per month will be awarded to the student of B.V.Sc. & A.H. programme of College of Veterinary Sciences, Ludhiana, who secures admission to M.V.Sc. programme at GADVASU, Ludhiana and has scored highest OGPA without failure.

#### 10.2 Stipend

The students enrolled for Ph.D. programme and not in receipt of any fellowship, etc. shall be awarded a stipend of Rs. 1500/- per month on fulfillment of the prescribed conditions.

#### 10.3 Fellowships

### (a) University Merit Fellowship

The University offers fellowships to postgraduate students. The value and number of fellowships for each department is determined by the Academic Council/Board of Management. Currently, the value of each fellowship is Rs. 4000/- per month in Master's programmes and Rs. 6000/- per month in Ph.D. programmes of the university. One fellowship is awarded for every 4 students or a part thereof in each department in Master's programmes, and one fellowship in each class/discipline for every 4 students or a part thereof in each department in Ph.D. programmes.

#### (b) Sri Guru Amar Das Ji Fellowship

This fellowship will be awarded @ Rs. 1000/- per month to one M.V.Sc. student on merit basis, from any discipline of Veterinary College, who has obtained the highest OCPA in B.V.Sc. & A.H. amongst the eligible applicants for this fellowship and whose family income does not exceed Rs. 6.0 lakhs per annum. The fellowship will start from the commencement of M.V.Sc. degree and will be awarded till two academic years in which the student has enrolled.

#### (c) Dr. Jugraj Singh Dhillon Fellowship

One fellowship @ Rs. 3000/- per month will be awarded on merit basis to an M.V.Sc. student majoring in the discipline of Animal Genetics and Breeding.

#### 10.4 Awards

#### (a) Mata Ind Kaur Award

A cash award up to a maximum of Rs. 10,000/- per annum will be awarded to three meritorious B.F.Sc. students who have achieved maximum OCPA, but not less than 7.00 out of 10.00, at the end of 1st, 2nd and 3rd year of the degree programme and who are not in receipt of any other fellowship.

#### (b) Dr. Balwant Singh Memorial Award

The award will be awarded to three students of B.V.Sc & A.H. degree programme who have secured 1st, 2nd and 3rd positions on the basis of marks obtained in the course of Veterinary Pathology offered during second professional year of B.V.Sc &A.H. degree programme and have enrolled in third professional year.

#### (c) Amar-Gian Award

A cash award upto a maximum of Rs. 11,000/- per annum with a certificate will be awarded to one male and one female student having Highest OCPA/OGPA in

B.V.Sc. & A. H on completion of degree, and one male and one female Best Athelete (total four awards) from amongst the students of constituent colleges of the university.

### Note for all Scholarships/Fellowships:

- Each student can avail only one fellowship/scholarship irrespective of his/her eligibility. The eligibility for the fellowship/scholarship will be determined considering the detailed guidelines for institution of the specific fellowship/ scholarship.
- 2. University scholarship, fellowship and stipends will be awarded to the students of domicile of Punjab & UT Chandigarh and/or having qualifying degree from GADVASU.

#### 10.5 Merit Certificates

Merit Certificates are awarded to the students who achieve an OCPA/OGPA of 8.00 or more out of 10.00 at the end of their Bachelor's or Master's Degree Programme.

#### 10.6 Gold Medals and Medals

The Gold Medals are conferred at the time of Convocation/Annual Function as under:

#### A. Undergraduate Programmes

#### (a) University Gold Medals

The college level Gold Medal is awarded to a student securing highest OCPA/OGPA (but not less than 8.00 out of 10.00) in the class in the programmes of constituent colleges.

- (i) B.V.Sc. & A.H Ludhiana
- (ii) B.V.Sc. & A.H Rampura Phul
- (iii) B.F.Sc.
- (iv) B.Tech. (Dairy Technology)
- (v) B.Tech. (Biotechnology)

### (b) Other gold medals

#### (i) Dr. Balwant Singh Gold Medal

The Medal is awarded to an all-round best graduate student among all the constituent colleges of the university.

#### (ii) Dr. Kulbir Singh Sandhu Meritorious Medal

The Medal will be awarded to an Overall Outstanding Fisheries Graduate (B.F.Sc.) of College of Fisheries, GADVASU, Ludhiana.

#### **B.** Postgraduate Programmes

#### (a) University Gold Medals

#### (i) Dr. S. C. Dutt Gold Medal

The Medal is awarded to a student who secures the highest OGPA (but not less than 8.00 out of 10) among all the M.V.Sc. programmes of the university in a given academic session.

### (b) Other gold medals

#### (i) Dr. G.S. Sidhu Medal

The Medal is awarded to a student for excellence in M.V.Sc. in the discipline of Animal Nutrition.

#### (ii) Dr. S.S. Dhillon Gold Medal

The Medal is awarded to a student for excellence in M.V.Sc. in the discipline of Veterinary Microbiology.

#### (iii) Dr. R.D. Sharma Gold Medal

The Medal is awarded to a student for excellence in M.V.Sc. in the disciplines of Animal Reproduction Gynaecology & Obstetrics.

#### (iv) Bibi Amar Kaur Kang Gold Medal

The Medal is awarded to a student for excellence among all the Master's degree Programme (M.Tech/M.Sc.) in the College of Dairy Science and Technology.

#### (v) Simrat Sagar Singh Gold Medal

The Medal is awarded to a student for excellence in M.V.Sc. in the discipline of Veterinary Surgery & Radiology.

Note: The eligibility for Gold Medals will be determined considering the detailed guidelines for specific Gold Medals.

#### **ANNEXURE – A**

#### CRITERIA FOR ADMISSION OF OUTSTANDING SPORTSPERSONS & NCC CADETS

#### A. Undergraduate Programmes

- 1. The candidates applying for admission to undergraduate programmes under sportsperson category shall have to obtain a gradation certificate from the Sports Department, Government of Punjab for their performance at 10+1 and 10+2 level in sports as specified in Annexure D. No weightage for sports will be given to the candidates who have participated after 10+2 level. Only the participation in the academic year of passing 10+2 and the preceding year will be considered.
- 2. The candidates admitted to B.V.Sc. & A.H. programme under the sports person category shall attend the play-field during hours other than those scheduled for compulsory R & V Sqn. N.C.C. However, participation in inter-class, inter-college, inter-varsity, State and National tournaments shall be governed by rules as applicable to other academic and co-curricular activities.

#### **B.** Postgraduate Programmes

#### (a) Outstanding Sportspersons

- 1. The order of preference in the selection of outstanding sportspersons for admission to the postgraduate programmes shall be made as per Annexure- B (i). For example, the candidate qualifying for grade 'O' shall be placed at higher merit than the candidate qualifying for grade 'A' followed by grade B and so on.
- 2. In case of individual sports discipline, position of the candidate in an individual event shall be considered and not the position of the team as a whole.
- The candidate should have participated at least twice in the University Inter-College Tournament, if held and once in the All India Inter-Varsity/North Zone Inter-Varsity Tournament/All India Inter-Agricultural University sports and games meet to be eligible for admission under sports category.

#### (b) NCC Cadets

The order of preference in the selection of NCC cadets for admission to the postgraduate programmes shall be made as per Annexure- B (ii). For example, the candidate qualifying for grade 'O' shall be placed at higher merit than the candidate qualifying for grade 'A' followed by grade B and so on.

#### Note (UG and PG Programmes):

- (i) For admission under the Sportspersons/NCC Cadets category, a provisional merit list of eligible candidates will be prepared by the Sports Committee constituted by the DSW-cum- Estate Officer. The shortlisted Sportspersons in order of merit, three times the number of available seats, will have to undergo trials for satisfactory performance. The trials will be videographed, and obtaining a satisfactory grading in the trials will be mandatory for admission under sports quota.
- (ii) Only those games/disciplines will be considered for admission under sports category, which are listed in Annexure- D.
- (iii) The candidate seeking admission under Sportspersons/ NCC Cadets category shall be required to submit self-declaration (Annexure-C) regarding his/her achievements in sports. If the candidate is a minor, declaration has to be made by the parents/guardian in respect of child's/ward's achievements in sports.
- (iv) The admission of the candidate under the Sportspersons/ NCC Cadets category shall be made on the explicit understanding that after joining the university, he or she shall attend the play fields regularly and shall also participate in various tournaments. If the candidates fail to do so, his/her admission may be cancelled.
- (v) In case of two or more candidates are obtaining similar grades in Sportspersons/NCC Cadets category, the following criteria will be used to determine the merit of selection for admission under Sportspersons/NCC Cadets category:
  - (a) The candidate winning the higher position in a competition of the same level will be placed higher followed by
  - (b) The candidate representing the competitions at the same level more times followed by
  - (c) The candidate having higher rank/marks in qualifying test/examination as applicable followed by
  - (d) The candidate senior in age

#### 1. Residence Certificate

Copy of letter No.1/3/95-3PPII/9619 dated 06.06.1996 from the Deputy Secretary, Personnel, Government of Punjab, Department of Personnel and Administrative Reforms (Personnel Policies-II Branch) to

- (i) All the Financial Commissioners to the Government of Punjab.
- (ii) All the Principal Secretaries/Administrative Secretaries to Govt. of Punjab
- (iii) All Heads of Departments, Commissioners of Divisions, Registrar, Punjab and Haryana High Court, District and Session Judges, Deputy Commissioners, Sub Divisional Officers (Civil) in the Punjab State.

Subject: Bonafide Resident of Punjab Guidelines for Grant of Resident Certificate

As per the Punjab Government Circular letter No.1/3/95-3PPII/2043, dated 29.1.1996 vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institutions (including technical/medical institutions). The matter has been reconsidered in the light of judgement delivered by Hon'ble Supreme Court of India in the case of Dr. Pardeep Jain vs. Union of India and others reported as AIR 1984-SC-1421 wherein it was held that instead of the word 'Domicile' the word 'Residence' be used in the instructions issued by the State Governments on the subject. Accordingly, it has been decided by the Government to revise the Government instructions referred to above as under:

- (b) Produce an affidavit to the effect that they or their children/wards have not obtained the benefit of residence in any other State
- : Self declaration of the Parents/Guardian (Annexure VII)


