A. Registration as a new IBSC/ Constitution of IBSC

The utmost authority of an organization working with GE microorganisms/ cells should register an IBSC through this portal, thereafter, a parent user id (**Organization's permanent login id**) shall be issued. Follow steps as mentioned for Registration as a new IBSC/ Constitution of IBSC.

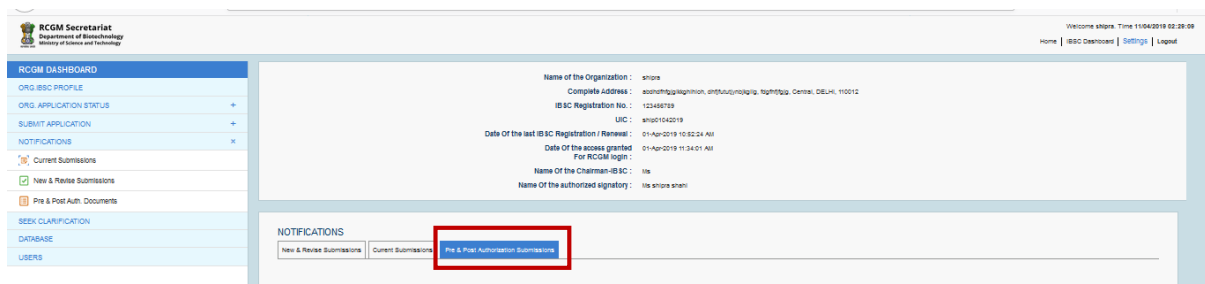
