Terms & Conditions

1. The rates quoted should be including all taxes and no extra tax and (C) or (D) form will be paid/given. The rates of the items must be quoted with all the terms & conditions and must be FOR GADVASU, Ludhiana destination basis and should include all types of taxes and charges.
2. The Maize Green Fodder with whole cobs to be supplied should be in good quality and free from fungus and any other adulterants. **In case it do not meet the physical standards, consignment will be returned immediately.** Further, the supplied Maize Green Fodder will be analyzed for proximate analysis in the university lab and only the consignment meeting the desired specifications will be accepted. The test report from the university lab will be taken as final for decision on acceptance/ rejection of consignment.
3. Incomplete tenders, without agreement to specifications name or received after due date /time shall be rejected. University does not take any responsibility for any delay.
4. Conditional and unsigned tender will not be accepted.
5. Delivery period of the items must also be intimated clearly in the tender, no further correspondence in this regard will be communicated by the University.
6. The tender shall not contain corrections, erasers and overwriting, it will result in rejection of tender straightway.
7. The University reserves all the rights to accept or reject any/all tender(s) and to increase or decrease quantity or configuration of items specified without specifying any reason. No correspondence will be made on this matter.
8. Above mentioned Quantity is tentative and can be increased/decreased to any extent or can be totally omitted according to sanctioned amount & the firm will have no claim on this account.
9. In case of failure of fodder sample for desired specifications, the supplier has to exchange the fodder on next working days, which will be retested in the university lab for quality check. In this case, the supplier will be charged Rs. 5000/-, deductible from the earnest money.
10. In case, the second consignment also does not meet the desired specifications, the supplier will be charged Rs.10,000/-, and the university will have the right to procure the same ingredient from other supplier. In this case, the difference in the cost of ingredient if any will be borne by the original supplier i.e. L-I. Further, the supplier has to lift the rejected Maize Green Fodder within 02 days of intimation. Thereafter, the university will have the right to dispose of the rejected consignment as per convenience, and university will not be responsible for any damage/loss of Maize Green Fodder.
11. University reserves the right to reject any or all tenders without giving any reason.
12. Tender rates will be valid up to 25 days from the date of opening of tender.
13. The supply of the material ordered has to be made up to minimum of 95% of the ordered quantity within 25 days of confirmation of order. On a single day maximum quantity supplied should be 500qtls.
14. The standing committee will open tender of only those firms whose tender is found to be in order.
15. Any detail regarding the item/material can be obtained from office of the Director, Livestock Farms, GADVASU, Ludhiana"
